Plan Design:

An **Employee** may receive elect minimum **\$20,000** to the lesser of 5 times Earnings to **\$500,000**. Every employee can elect up to \$100,000 without Evidence of Insurability form.

Spouse's coverage is increasing to the lesser of 50% of the Employee's election amount or **\$100,000**. Election above \$25,000 require Evidence of Insurability form.

Dependent Child(ren) will have the opportunity to elect \$10,000, costs of \$2.91 per month.
