## HEALTH INSURANCE

The District offers health insurance to employees through TRS ActiveCare. The plan administrator is Blue Cross Blue Shield of Texas (BCBSTX).

The health coverage plan year is September 1 to August 31 with open enrollment held annually in August. The minimum required employer contribution to the monthly premium is $\$ 225.00$. In order to enhance employee recruitment and retention, an additional amount is provided to employees for health coverage.

For 2023-2024, the monthly employer contribution is a maximum of $\$ 575.00$. All employees are paid semi-monthly, so the premium deduction is divided evenly between the two pay checks each month. Below is a summary of the health plan premiums.
