

# Benefits Annual Enrollment Information and Changes for 2023-2024

- Benefits Annual Enrollment: July 10<sup>th</sup> Aug 23<sup>rd</sup>.
- OPEN ENROLLMENT

Flexible

Spending Account

- Our health plan is changing from TRS ActiveCare to BCBS/Trustmark.
  - Same BCBS Network.
  - o Premiums/rates will remain the same.
  - NEW! Nationwide Network for all plans.
  - NEW! No need to designate a Primary Care Physician (PCP).
  - o The Baylor Scott & White HMO Plan is going away.
  - New pre-authorizations for medical and Rx will be required for the new plan year 9/1/23.
- We are changing health savings account providers from HSA Bank to EECU.
  - NEW! \$0 employee cost for bank account.
  - <u>Current health savings plan participants MUST enroll in a new HSA account for the new plan year if they want to continue contributing.</u>
  - Separate information will be mailed to current HSA Bank plan participants to let them know options for current account.
- We anticipate a rate increase for Short Term Disability.
- <u>We encourage everyone</u> to go online to verify your previous benefit elections and beneficiary information.
- If you want to add, change, or cancel a benefit election, you must log into FFEnroll.
- If you want to add or delete a dependent from a benefit coverage, you must log into FFEnroll.
- If you do not want to enroll in the MISD health insurance, you must go online and waive the health coverage each annual enrollment.
- Once your enrollment is complete, you will receive a confirmation email. Please confirm your benefit elections to make sure they are accurate.

# Flexible Spending (Healthcare & Dependent Care FSA Provider: TaxSaver)

- If you want to participate in the flexible spending program, you must reenroll.
- Plan year 9/1/23 8/31/24: Only eligible expenses and services incurred during this time can be claimed.
- Be conservative in funding this account. Use it or lose it.
- Documentation may be required for each debit card expenditure.

- This is a <u>full-coverage flex account</u>; so, if your spouse has a health-savings account/HSA account (either through his/her employer or on his/her own), you are not eligible to enroll in this plan/benefit.
- When enrolling in this benefit in *FFEnroll*, make sure you elect the <u>HealthCare FSA account</u> with TaxSaver (not the Health Savings Account/HSA).

## **Health Savings Account is Changing Providers to EECU**

- If you want to participate in the health savings account, <u>you must re-enroll</u> this plan year.
- Plan year 9/1/23 8/31/24.
- When enrolling in this benefit in *FFEnroll*, make sure you elect the Health Savings Account with EECU.
- You can use your HSA card at the MEHC for a \$15 cash price office visit (or \$30 for cosmetic service office visit)!
- HSA plan participants are *not eligible* for any Rx district contributions.
