**Eligibility**

All Active Full Time Employees who regularly work 20 hours per week are eligible for insurance on their date of hire.

**Supplemental Life and AD&D**

Employee Benefit: **\$10,000 to \$500,000 in \$10,000 increments.**  
**Not to exceed 7 times annual earnings.**

Spouse Benefit: **\$5,000 to \$250,000 in \$5,000 increments.**  
**(not to exceed 50% of the employee benefit)**

Note: Spouse may not have coverage unless the employee has coverage.

**Guarantee Issue\***

Employee **\$150,000** under age 60, \$10,000 age 60 & over.  
Spouse **\$50,000** under age 60.

**\*NEW HIRES ONLY**

**Child Coverage**

Birth to 14 days: **NONE**  
15 days to Age 26: **\$5,000 or \$10,000**

Employee: Life & AD&D benefits reduce by 50% of the original amount at age 70.  
All benefits terminate at retirement

Spouse: Life Benefits terminate at Employee Age 70.
