#### How to Register

You and any eligible dependents can register to use Smile for Health®-Wellness any time after your insurance plan's effective date. Here's how:

- Sign into **MyDentalBenefits** (or create an account)
- Click the **Wellness** tab at the top menu
- Click the **+Add a new condition** and complete the fields as prompted
- Your condition status will show as **ACTIVE** to confirm your activation
