



Aetna Prescription Plan

The City of Cedar Park offers a comprehensive prescription drug benefit, which covers prescription care needs at participating pharmacies and mail-order maintenance drugs. Aetna CVS Pharmacy is the carrier of service. Participants enrolled on the Medical PPO or HDHP are automatically enrolled in the Aetna prescription drug plan. Participants enrolled on the Medical HDHP are subject to a deductible and coinsurance for all medications filled through an Aetna retail and mail order facility.

The generic, preferred, or non-preferred list of covered drugs is reviewed periodically resulting in changes to the prescription drug list throughout the year. If you are taking a medication that is affected by one of these changes, Aetna will mail a letter to your address on file to alert you of the change in benefits. Scriptsourcing Prescription

Participants enrolled on the medical group plan have access to the Scriptsourcing prescription program. Scriptsourcing partners with Aetna to provide competitive pricing and access to name brand and expensive specialty medications.

The Scriptsourcing program allows employees and dependents to pay \$0 copay for eligible maintenance medications dispensed through mail order. Prescriptions are shipped directly to the participants home free of shipping costs. Participants are notified about the program after the medication is prescribed and filled through an Aetna network pharmacy.

This prescription drug program offers 450+ brand name medications at \$0 copay. The Scriptsourcing formulary includes these medications:
