

Eligibility

All Active Full Time Employees who regularly work 10 hours per week & Bus Drivers are eligible for insurance on their date of hire.

Supplemental Life Insurance

Employee Benefit: \$10,000 - \$500,000 in \$10,000 increments, not to exceed 7 times

annual earnings.

Spouse Benefit: \$5,000 - \$250,000 in \$5,000 increments, but not to exceed

50% of the employee benefit.

Note: Spouse may not have coverage unless the employee has coverage.

Child Coverage

14 days to 6 months: \$250

6 months to 26 years: \$5,000 or \$10,000

Employee: Life Benefits reduce by 35% of the original amount at age 70, then by 55% at age

75, then by 70% at age 80, then by 80% at age 85, and 85% of the original amount

at age 90. Benefits terminate at retirement.

Spouse: Supplemental Life Benefits reduce by 35% of the original amount at Employee's age

65, then terminates at Employee's age 70.
