An accident prevention benefit is a cash benefit you can use to pay for exams, tests, screenings and programs for preventative care.

HOW DO I USE MY ACCIDENT PREVENTION BENEFIT?



STEP 1: CHECK ELIGIBILITY

Review the chart on page 1 to find out if your exams, tests, screenings and/or programs are eligible.



STEP 2: ORGANIZE INFORMATION

Prepare to file your claim.⁴ You'll need the following information:

- · Name, address and the group policy number
- Name of the exam, test, screening or program and the date completed; and
- Details of where the exam, test, screening or program was completed and physician contact information (if applicable).



STEP 3: FILE A CLAIM OVER THE PHONE OR BY MAIL OR FAX

- You can file your claim however you're most comfortable, over the phone with one of our claims professionals or by mail or fax.

STEP 4: LEAVE IT TO US

Once the claim has been approved, the standard turnaround time for benefits to be paid is 3-5 business days.⁵
